PARTICIPATION RULES

To participate in an IJF event, each participant is responsible to follow :

- The rules to enter the host country and the local government health measures

This Oceania Judo Open is open for all IJF Member Federations. There is no limit in the number of participants for each weight category for every federation. The competitors must be of the same nationality as the National Federation, which enters them.

Any participant is eligible to inscribe in the competition provided he/she is:

- Not under a disciplinary suspension
- Not under suspension for antidoping rule violation
- Not carrying any communicable diseases that may risk other delegates' health

In addition to the above athletes must:

- Not be under medical suspension
- Be healthy and fit for competition
- Born in 2010 and before (Minimum 15 years in the calendar year) or before. Any National Federation entering athletes that are not of the correct age will be subject to an investigation and possible disciplinary action.
- Have sufficient technical knowledge (know the terminology and can execute all the techniques in the and understand fully the IJF Sport and Organisation Rules - SOR. (https://78884ca60822a34fb0e6-082b8fd5551e97bc65e327988b444396.ssl.cf3.rackcdn.com/up/2025/01/IJF_Sport_and_Organisation_Rul-1738236032.pdf))

All participants must have a valid IJF card and be inscribed in judobase (<https://admin.judobase.org/>) by their national federation

ENTERING THE FRENCH POLYNESIA

To be admitted to French Polynesia, any foreign national who is not a national of the European Union must hold a passport whose validity must be longer than 3 months from the expiry date of the intended stay.

Most countries do not require a visa application, as long as foreigners hold a biometric passport. To know the list of countries that require a Visa application, you can consult the following link. Event inscription

In case of unforeseen delay of arrival or if cancellation from the event you must inform the OJU (sportdirector@oceaniajudo.com) and the LOC (by email or phone call) and write an email to registration@ijf.org.

Whenever possible, cancellations should be made before accreditation. Any cancellation of an athlete during accreditation without replacement will result in the following penalty:

- If registered athletes are cancelled during accreditation without previous notification as abovementioned, a penalty of 100 US\$ per athlete will apply
- This penalty will be charged by the OJU to the National Federation

Competition system is elimination system with the quarterfinal (last 8) repechage. The competition will be carried out according to the rules and sporting codes of the IJF and OJU.

Draw

The draw will be held ONLINE. The top eight from the entered competitors in each weight category will be seeded according to the current IJF World Ranking List.

Weigh-in

Official weigh-in for each weight category is held the evening before the competition day (see program). Athletes must present their OJU accreditation card and their passport (National ID Cards showing nationality, picture and date of birth are also accepted).

Official scales or test scales will be available for test weigh-in on Friday and Saturday from 08:00 to 22:00 (except during official weigh-in from 17:30 to 18:30).

Accreditation & Control of Nationality

A maximum of two team delegates shall attend the accreditation on Friday from 10:00 to 17:00 in order to confirm the entries of all athletes and officials. A delayed appearance or no-show may result in the exclusion of all participants from the draw and the event. In case of unforeseen delay of arrival, the National Federation must immediately contact the LOC organisers, the OJU (sportdirector@oceaniajudo.com) and writing a mail to regitration@ijf.org. Passports or photocopies of passports from all competitors must be available on request (national ID Card showing nationality, picture and date of birth or a copy is also accepted). The presence to the competitors it is not necessary at the accreditation.

Very important: Each National Federation must be represented by a team leader or coach responsible for registration of ALL athletes from the respective National Federation, regardless club or other membership. Every National Federation will be accepted for accreditation only once, when all entries and payments can be confirmed at the same time.

An accreditation card is issued by the OJU during the official registration for each member of a delegation (athlete, coach, team official, doctor etc.). A delegate should never wear another delegate's accreditation card. This remains property of the OJU and can be withdrawn, with immediate effect, at the OJU's sole discretion.

If an athlete loses his/her accreditation, he/she must immediately inform the LOC to obtain a new card following the payment of US\$20

Judogi Control



Approved Judogi

All Judoka must compete in IJF Approved Judogi (see SOR Appendix C). Judogis from all IJF suppliers are allowed (see www.ijf.org/supplier-list).

Judogi Control

It will be operated with a Sokuteiki prior to the contests. Judogi must have an IJF Official Label "APPROVED JUDOGI" with an optical code which cannot be falsified. The label will be controlled with an optical lamp. Each of the competition clothing articles (jacket, trousers and belt) must have an IJF official label.

Backnumber

Each competitor taking part in the OJU events is obliged to have sewn on the back of his Judogi the official backnumber (both OJU and IJF are allowed) bearing his surname and his National Olympic Committee abbreviation. The backnumber can be ordered from www.mybacknumber.com or www.officialbacknumber.com (attention: production and delivery may take around 4 weeks). The SPONSOR part (if needed) will be given to the head of delegation during registration, and the athletes can stick it themselves using the special glue on the back number.

Markings and Advertising

For all concerning the judogi and sponsors rules please refer to IJF SOR Appendix C.

Important:

- If an athlete does not respect the Judogi rules, the athlete will not be permitted to pass the Judogi Control, and the coach who is responsible for the athlete will be suspended for the rest of the competition day.
- The organiser is not obliged to provide reserve Judogi at Judogi Control, but the athlete is allowed to present himself in another IJF Approved Judogi, complying with the Sokuteiki rule (and without backnumber) - in this case no coach can go with this athlete next to the tatami!
- In the case of a repeated offence the coach will be suspended for the rest of the competition.

Responsibility of federations

The competitors will compete under the full responsibility of their federations.

Insurance: Each national federation is responsible for insuring its competitors against “injury and third part risk (public liability)” during the period of the event. The Oceania Judo Union and the organiser decline all responsibility.

Consent for Photography/Videos/Filming

Delegates inscribed by their National Federations for OJU events consent to the OJU and its media partners to use content of them, including data, live results, photographs and/or video recordings (hereafter referred to as Media). This media may be obtained from National Federations and OJU. It will also be acquired by the OJU and its media partners from in and around all OJU event venues. Media could be used in print and digital media formats including print publications, websites, eMarketing, posters banners, advertising, film, broadcast, social media, education purposes and other purposes. The National Federation must ensure that they have the permission of each delegate or in the case of a minor the permission of the parent/guardian. If a delegate does not give consent, then the National Federation must inform the Oceania Judo Union by writing to headoffice@oju.net.

Medals

First place - Gold medal

Second place - Silver medal

Third places (x2) - Bronze medals

World ranking points

An athlete is in the competition only once they pass the official weigh-in. If an athlete passes the official weigh-in and is alone in the category he/she will get the participation ranking points. Any athlete who does not come to the tatami for a contest will have a line put through his/her name on the draw sheet. His/her opponent must come to the tatami and bow. He/she will be declared the winner by fusen-gachi and WRL points will be given.

Anti-Doping

Doping control will be executed according to the IJF Medical and Anti-Doping Handbook (IJF SOR – Appendix E).

Coaching

All coaches must fully adhere to the Code of Conduct for Judo Coaches.

Dress Code Elimination rounds:

National track suit with trousers reaching down to shoes or jacket suit with tie

Dress Code Final block:

Jacket suit with tie



Awarding ceremony

Each athlete who has won a medal must be present at the ceremony to receive their medal personally. Any athlete who is absent from the awards ceremony without a good reason may forfeit the medal

Athletes must attend the medal ceremony barefoot, without any hat, cap or any similar head covering and wearing their IJF approved white judogi that conforms to the IJF judogi rules with special attention being paid to the publicity rule. If it is not clean, then they must wear a reserve judogi.

Insurance

Each national federation is directly responsible for all its delegates registered on Judobase for any event. It must assume all responsibility for accident, health and civil liability insurance for everyone under their charge during events.

National federations are responsible to provide insurance guarantees to their delegates during any IJF event. If the national federation does not provide insurance to the members of their delegation, those members shall be liable for any damages caused by or incurred to them.

The LOC of the event and the IJF will not be responsible in the absence of insurance.

The LOC of the event and the IJF accept no liability for any claims of injury, illness or death arising from the travelling to and the participation in this event nor any claims relating to the cancellation of the event or medical costs related to illness that may affect a participant during the event.
