6. Visa

To ensure the smooth insurance of visas, all the delegates should email the Visa Application and copies of passport to the Judo Association of Thailand, through email thaijudocompetition@gmail.com no later than 18th March, 2025

The LOC will assist with visas where possible but having the correct visa is the responsibility of each participant. Visa applications will only be accepted for people who are inscribed in judobase for the event.

It is the responsibility of the National Federation to ensure that their delegation respects the conditions of stay defined by the Government of the country hosting the event. If any participant does not respect these conditions, any costs arising will be borne by the National Federation concerned.

Please note that visa approvals or rejections are done by the Government authorities and the LOC has no control over this and cannot be held responsible for any rejections.

7. Fundamental principles:

All event participants participating in the event described in these outlines must respect and accept the authority of the Judo Union of Asia (JUA) officials, the JUA Statutes, the IJF and JUA Sport and Organisation Rules SOR and the IJF and JUA Anti-Doping Rules. Individuals deemed to have acted against the IJF, its principles or purposes should be subject to suspension or expulsion from the event and/or cancellation of their accreditation cards.

8. Participation rules:

This Asian Judo Championships 2025 is open for all JUA Member Federations/Associations.

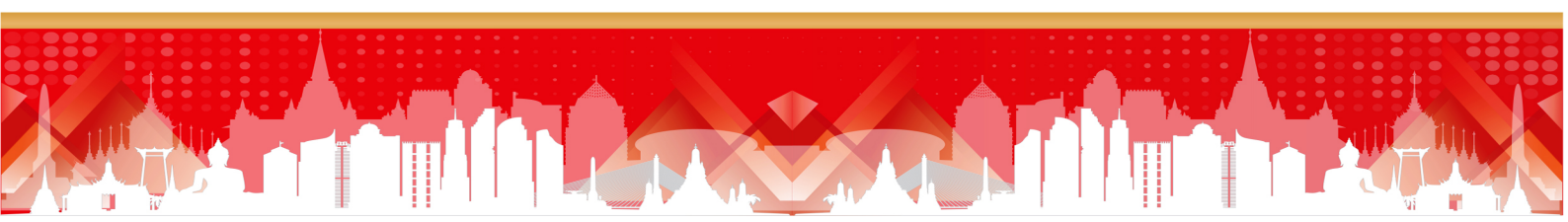
Each Federation/Association may enter a maximum of 2 (two) competitors per weight category, up to a total number of 9 men & 9 women. The competitors must be of the same nationality as the National Federation/Association, which enters them.

All participants and delegates must be registered for this event in the IJF Registration System (JUDOBASE): <https://admin.judobase.org/>

Deadline for JUDOBASE Registration is 14th April 2025.

Any delegate is eligible to inscribe in the competition provided he/she is:

- Not under a disciplinary suspension.

- Not under suspension for anti-doping rule violation.
- Not under medical suspension.
- Healthy and fit for competition.
- Do not carry any communicable diseases that may risk other delegates' health.
- Participating athletes must be born in 2010 (15 years old or over in the calendar year).
- Sufficient technical knowledge (know the terminology and can execute all the techniques in the IJF SOR Appendix H) and understand fully the IJF sport and refereeing rules.

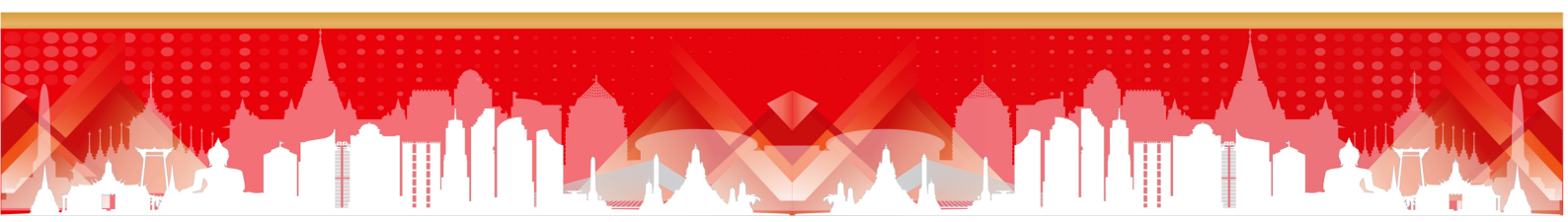

Note: Hotel reservations are made ONLY through the LOC (Local Organizing Committee) on a first come first serve basis. Hotel reservations must be made before 1st April 2025 with full payment by bank transfer, subject to the following terms and conditions.

“According to the new IJF rule enacted on the December 2, 2012 in Tokyo, country should not request fee penalties for countries which cannot make bank transfer but can pay in cash money upon arrival. On the other hand, they should inform well in advance the organizing country and specify the number of participants before the deadline.”

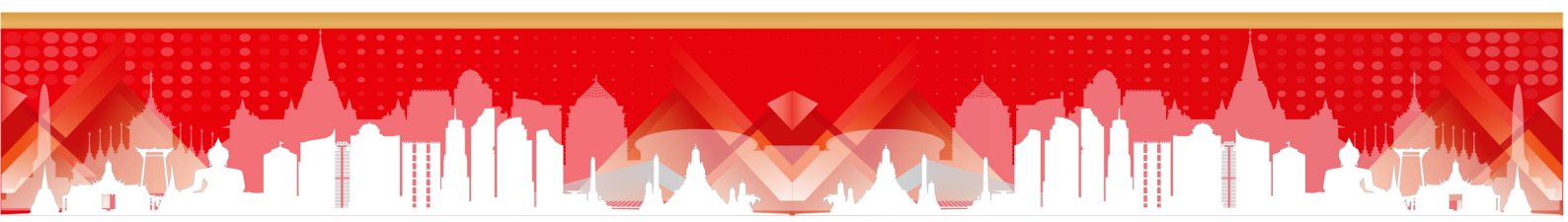
Cancellation fees: up to 20 days before the hotel payment deadline, full refund. After the 3rd April, 2025 any cancellation of rooms reserved or no-show will result in 100% of the charge of the hotel costs that must be paid by the participating National Federation. Cancellations of the rooms cannot be made at the check-in. Injuries, visa problems or sickness are not valid reasons for cancellation or rooms.

IMPORTANT RULE: All damages to property of hotels or venues resulting from the stay of a delegations shall be charged to federation and paid in full.

*All bank fees and bank transfer costs must be paid by the participating national federation.

If payment is being made by bank transfer the bank information must be inserted correctly and completely on the transfer document and any procedures related to amendment of the bank transfer must be done before arrival. Delegations must ensure that all bank charges are paid at their end so that the LOC receive the correct amount of funds without any deductions. Delegation must have proof of the bank transfer, upon arrival.

In the case of non-payment to the LOC, the national federation concerned will not be allowed to register to competitions until the debt is settled.

11. Inscription fees

An inscription fee of US\$100 (one hundred) per weight category (Individual) and US\$500 (five hundred) per team (mixed team) must be paid to the JUA General Treasurer, at the time of accreditation. As a last resort these fees can be paid at the Delegation Meeting for the championships. After the Delegation Meeting, under no condition refunds can be given.

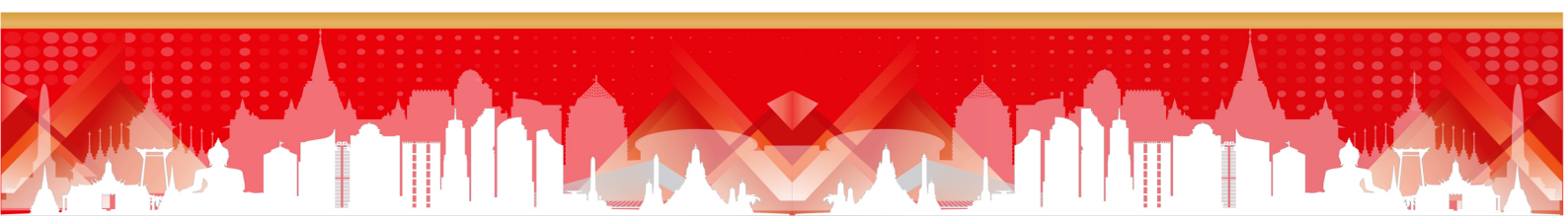
13. Categories & Duration of Contest

Men	-60kg, -66kg, -73kg, -81kg, -90kg, -100kg, +100kg
Women	-48kg, -52kg, -57kg, -63kg, -70kg, -78kg, +78kg

14. Mixed team competition:

According to the IJF and JUA SOR, for mixed team competition, each team will consist of 6 (six) competitors (3 men and 3 women) and the weight categories should be as follows:

Men (3):

-73kg (up to and including 73kg)
-90kg (over 73kg up to and including 90kg)
+90kg (over 90kg)

Women (3):

-57kg (up to and including 57kg)
-70kg (over 57kg up to and including 70kg)
+70 kg (over 70kg)

15. Age

Men and Women of 15 years old or above (Calendar year) (must be born in 2010 or before).

16. Insurance

Each National Federation is directly responsible for its athletes (the control of non-pregnancy and the control of gender). It must assume all responsibility for accident and health insurance as well as civil liabilities during all JUA events for everyone under their charge.

National Federation are responsible to provide insurance guarantees to their delegates during any JUA event. The LOC of the event and the JUA will not be responsible in the absence of insurance. The entity contractually bound to the JUA for the organization of the event shall take all necessary actions to provide insurance coverage against civil liability for the entire duration.

It is the responsibility of the National Federation to ensure that in addition to their normal insurance they have sufficient insurance in place to cover any COVID-19 related costs, including repatriation.

The LOC of the event and the JUA accept no liability for any claims of injury, illness or death arising from the travelling to and the participation in this event nor any claims relating to the cancellation of the event due to COVID-19 or medical costs for any COVID-19 related illness that may affect a National Federation delegation member during this event.

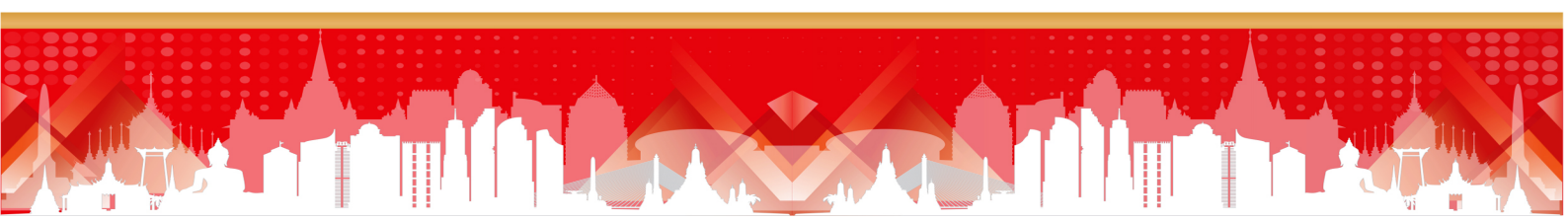
17. Competition rules:

Competition will be conducted in accordance with the IJF and JUA Sports and Organization Rules, and IJF Refereeing Rules.

System of competition: quarter-final (last 8) repechage, duration of contests: four (4) minutes (real time). The “Golden score” with no time limit. The national federation is responsible for obtaining legal approval and permission for minor athletes to compete in competitions. When travelling with minors the team official/coach must have all the necessary documents in place that authorises them to act on behalf of the parents/guardians “in loco parentis”.

This also applies to doping control. The national federation must ensure that minor athletes have their parental/guardian permission to undergo testing.

18. Weigh-In

The weigh-in will be carried out in accordance with the IJF & JUA SOR

The athlete's official weigh in will be scheduled the day before the competition.

- **Unofficial weigh-in: 15:20 - 15:50 (the day before competition)**
- **Official weigh-in: 16:00 - 16:30 (the day before competition)**

First day weigh-in will be held in the **Al Meroz Hotel** (Official hotel), and for the other days the weigh-in will be carried out in the Venue (MCC Hall).

Random weigh-in will take place one hour before the start of the competition each day. The athletes must bring their accreditation for identification. The weight of the athlete cannot be more than 5% higher than the official maximum weight limit of the category.

19. Draw

The draw will be held at 14:00 on 24 April in Al Meroz Hotel.

Each National Federation must send a delegate to attend the Draw, a maximum of two (2) delegates per National Federation (2 officials) will be authorized.

20. Coaching

Coaches nominated by their national federations should respect the IJF/JUA Code of Ethics and IJF/JUA SOR. Any coaches not adhering to these rules could be subject to disciplinary action.

21. Awarding ceremony

Each athlete who has won a medal must be present at the ceremony to receive their medal personally. Any athlete who is absent from the awards ceremony without a good reason may forfeit the medal and prize money.

Athletes must attend the medal ceremony barefoot, without any hat, cap or any similar head covering and wearing their white judogi with special attention being paid to the publicity rule. If it is not clean, then they must wear a reserve judogi.

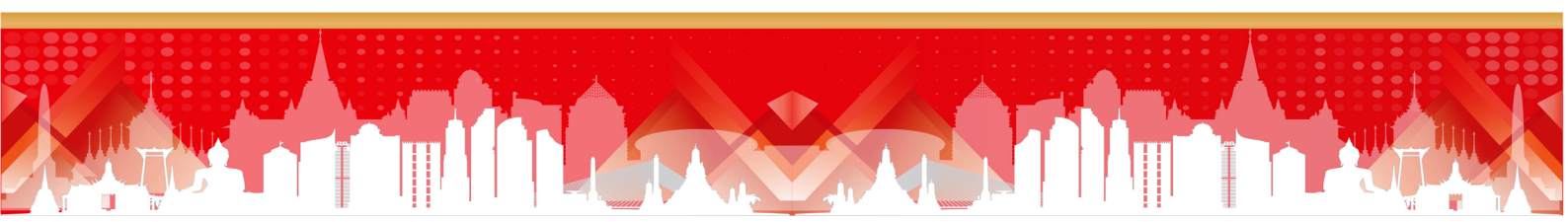
It is strictly prohibited for athletes on the podium to have national flags or similar items other than those on their judogi. Any demonstration with religious, political, personal or commercial connotation is prohibited.

Athletes must also be available for interview after the last awarding ceremony if requested by the JUA Media Team.

22. Nationality

Contestant must hold the same nationality of their Federation. Contestants are required to show his / her passport to confirm their nationality.

23. Judogi & Backnumber

In accordance with the IJF and JUA regulations.

24. Responsibility of national federations

The competitors will compete under the full responsibility of their federations.

Insurance: Each national federation is responsible for insuring its competitors against “injury and third part risk (public liability)” during the period of the event. The Judo Union of Asia and the LOC decline all responsibility.

25. Anti-doping

The Anti-Doping Control for individual competitions and mixed team competition will be carried out in accordance with the IJF Anti-Doping Rules and JUA Sports Organization Rules.

Pursuant to WADA ISTI Art. 5.4.4, prior to doping control, athletes can take part in the awarding ceremony and fulfil their press commitments or receive medical treatment if needed.

The selected competitors will be constantly accompanied by an official chaperone (appointed by the organising committee) from the time of notification until arriving at the doping control station. A person of the athletes’ choice (team doctor, coach, trainer, delegation head etc.) may accompany them. JUA keep the right to test any participating athlete beyond the above selection during an event.

All additional tests are deemed in-competition tests. At its own discretion JUA may allow Testing Authorities to conduct out-of-competition tests as well.
