## I. General Information

### 1. Introduction to the 20th Asian Games Aichi-Nagoya 2026

Date: 19 September to 4 October 2026

Host City: Aichi-Nagoya

Sports: 41 sports

Venues: 53 competition venues, 72 training venues

Concept:

- Athlete-Centered
- Using existing facilities
- Making full use of state-of-the-art technology
- Offer hospitality with traditions through interaction with citizens
- Contribute to the promotion of sports culture

#### 1.1. Emblem

The smooth curves describe the liveliness of sports.

The center line colored in purple, gold, and green inspires the image that people get together as one and go forward to the future by heading to a bright red sun, the symbol of the OCA. The purple is used as an image of iris which is the prefectural flower of Aichi. The gold describes the Kinshachi, the golden tiger-fish roof ornaments and the symbol of Nagoya Castle. And the green inspires the high environmental consciousness among people of Aichi-Nagoya fostered through EXPO 2005 Aichi, COP10, and the UNESCO World Conference on ESD. The emblem contains the initial letters of Asia, Aichi, and Nagoya. You can see "A" described by the purple curve and the center line and "N" in the purple and the gold.



## 1.2. Mascot

"HONOHON " was born from the fiery passion that dwells in the hearts of athletes, becoming one with Shachihoko, the guardian deity of Aichi-Nagoya.

The name "HONOHON" is derived from the word "Honoho," which is said to be the origin of the Japanese word meaning "flame," that comes from the image of fire rising high and burning brightly, resembling the shape of a rice ear ("ho" in Japanese). To make the name sound more friendly, we named it "HONOHON."

## 2. Accreditation and Validation

AINAGOC will distribute the Accreditation Guide to Responsible Organizations in December 2025. The Accreditation system will be available from XX December 2025 to XX May 2026.

From July 2026 onwards, AINAGOC will produce and deliver the Pre-valid Asian Games Identity and Accreditation Card (PVC) to Responsible Organizations that have confirmed their Accreditation Status Report. Upon arrival in Japan, Games stakeholders will be required to validate their PVC at the Aichi Sky Expo accreditation validation desk or other accreditation facilities by presenting their valid identity documents. Once validated, the PVC becomes the Asian Games Identity and Accreditation Card (AGIAC). The AGIAC entitles cardholders to access the venues and zones indicated on their card in order to perform their duties.

### 3. Validity Period of AGIACs

When accompanied by a valid passport (or equivalent document), PVC or AGIAC will serve as a visa waiver which allows multiple entries when applying for landing into Japan. The visa waiver period is 50 days before the Opening Ceremony to 15 days after the Closing Ceremony. Between 31 July 2026 and 19 October 2026.

### 4. Transport

Athletes and team officials will be provided with transport on arrival and departure, for competitions, and for training. Services will be available for the designated locations. AINAGOC will allocate a specific number of dedicated vehicles to each NOC delegation for its exclusive use. Please refer to the Detailed Transport Services Plan (to be published later) for the 20th Asian Games Aichi-Nagoya 2026 for more details.

### 5. Accommodation

A conventional athletes' village will not be built.

During the 20th Asian Games Aichi-Nagoya 2026, NOC athletes' and team officials will be accommodated at Garden Pier (Villas\*) and Kinjo Pier (cruise ship), and existing accommodation facilities (hotels, etc.), and necessary functions and services will be provided.

For security, access to the Athletes' Accommodations will require the appropriate accreditation card.

\*A facility that houses accommodation amenities within a container-sized unit, allowing for easy transportation via trailer or ship, and used as a hotel or private residence.

### 6. Media Services

#### 6.1. Broadcast Mixed Zone

All athletes are required to pass through the Broadcast Mixed Zone after the competition. However, athletes are not obligated to comply with interview requests in this area.

The Broadcast Mixed Zone is directly connected to the Press Mixed Zone, ensuring a seamless transition for athletes and media representatives.

**\*Victory Ceremony Procedure:**

If an athlete is scheduled to attend the victory ceremony, the Ceremony Producer or Sports Manager will notify the HB and Press Mixed Zone Manager. These athletes will then be escorted to the ceremony briefing area. After the victory ceremony, they will return to the Broadcast Mixed Zone and pass through the area.

## **6.2. Press Mixed Zone**

Athletes must pass through Press Mixed Zone at right after passing through Broadcast Mixed Zone so that they can be interviewed by accredited press as soon as possible after the competition ends. Athletes must undergo Doping test (included but not limited to) after passing through Press Mixed Zone. In case it's occurred after a Press conference, it must be conducted at after the Press Conference.

## **6.3. Press Conference Room**

After the final of each event, in principle, a post-competition press conference will be arranged. At Press conferences, interpreting in 6 languages (Japanese, English, Chinese, Korean, Russian and Arabic) will be provided. Translating a participant's native language into English, if needed, should be done by the Press Attaché(s) or staff of the relevant NOC taking part.

Athletes must undergo Doping test (included but not limited to) after passing through Press Mixed Zone. In case it's occurred after a Press conference, it must be conducted at after the Press Conference.

## **6.4. FOP Photo Positions**

FOP photo positions will be set up in FOPs or FOP surrounding areas in each competition venue. These positions are for accredited photographers to use to take photos of competitions. Accredited photographers will need to wear supplementary access control devices in order to enter FOP photo positions. During the victory ceremony, if necessary, set up a suitable temporary photo position to capture it.

## **6.5. NOC Press Attaché**

NOC press attachés with Supplementary access control device(s) will assist in facilitating

interviews between Athletes and Accredited press. They can enter the athletes' side of the Press Mixed Zone, but not the Broadcast Mixed Zone. Where necessary, language support volunteers assist them in their activities.

## 7. Medical Services

Medical Services During the Games, AINAGOC will run Medical rooms for athletes at each competition venue and provide onsite medical services and emergency transport.

At each athletes' accommodation, medical staff will be stationed to provide necessary care and treatment.

If advanced care and exam are needed, patients will be transferred to the Games' designated hospitals.

If necessary, medical services such as emergency treatment, hospitalization and emergency transfer will be provided.

Onsite Basic medical, emergency transport services will be provided free of charge.

Other medical services shall be paid for in accordance with the provisions stated in the relevant policy for insurance cover.

Free medical services will not include non-essential medical care nor elective medical treatment.

## II. Technical Information

### 1. Competition Date

The Judo competition of the 20th Asian Games will be held from 30 September to 3 October 2026.

The Judo competition will be held at Aichi International Arena, which consists of one (1) arena with 17,000 seats, and one (1) warm-up arena. The competition venue is xx.x kilometres away from the Athletes' accommodation. The competition venue will also be used as the training venue.

### 3. Competition Events

Women's Events (7) : -48kg, -52kg, -57kg, -63kg, -70kg, -78kg, +78kg

## 5. Competition Rules

The Judo competition of the 20th Asian Games Aichi-Nagoya 2026 will be held as per the latest technical and competition rules of the International Judo Federation (IJF) and the Judo Union of Asia (JUA).

Detailed information is available on the websites of the IJF: [www.ijf.org](http://www.ijf.org) and of the JUA: [thejua.org](http://thejua.org). In case of any disagreement in the interpretation of the IJF/JUA rules and regulations, the English version shall prevail.

Any unforeseen circumstances not covered by the regulations and rules shall be resolved as follows:

- Technical issues: Resolved in accordance with the IJF/JUA rules and regulations;
- General issues: Resolved in accordance with the Olympic Council of Asia (OCA) Constitution and Rules

## 6. Competition Format

The Individual competition adopts a single-elimination system with repechage starting at the quarter-final round.

Athletes will be divided into two (2) tables (A and B) by means of a draw, each of which includes two (2) groups, namely A1 and A2, B1 and B2. Winners in the quarter-finals will advance to the semi-finals while losers will compete in the two (2) repechage contests. Winners of the semi-finals (A and B) will compete for the gold medal. The winner of each of the two repechage contests will compete in a bronze medal contest against the semi-final loser (A and B) of the opposite table. Losers of the repechage contests will be placed equal seventh. Losers of the bronze medal contests will be placed equal fifth while winners will be awarded the bronze medals. The bronze medal and gold medal events will be held on one (1) mat respectively.

The Mixed Team event adopts a direct elimination system with repechage starting at the quarter-final round. The four (4) best teams will be seeded. The teams will be divided into two (2) tables by means of a draw, and an elimination system will be used to produce two (2) finalists, who will compete for the gold medal. Repechage matches allow the losers of the quarter-finals a chance to compete for the bronze medals. The teams defeated in the quarter-finals will compete in two (2) repechage matches. The winners of each of the two (2) tables will compete in a bronze medal match respectively against the winner of the two (2) repechage matches, and the loser of the semi-final matches of the opposite table. The winners of the bronze medal matches are awarded the bronze medals, and the losers are placed equal fifth. The losers of the repechage matches are placed equal seventh.

### 6.1. Competition Duration

The duration of each contest shall be four (4) minutes for both men's and women's events (actual time). There is no time limit for the Golden Score. Any existing score(s) and/or shido(s) from regular time are carried into the Golden Score period and will remain on the scoreboard. Golden score can only be won by a technical score (yuko, waza-ari or ippon) or hansokumake (direct or by accumulative shido).

## 6.2. Draw

The date and time of the draw will be determined jointly by AINAGOC and the JUA. The athlete weight category list will be posted outside the draw room after accreditation is completed and before the draw begins. Any errors or omissions should be reported to the Technical Delegate before the draw begins.

Each NOC may send up to two (2) delegates to attend the draw. Dress code: formal attire (jacket, trousers, shirt, and tie for men; jacket, trouser/skirt/dress, and blouse for women) and formal shoes.

Under the guidance of the Technical Delegate, the draw of lots will be conducted using a computer-based draw system with the help of JUA-appointed ITOs. AINAGOC shall distribute the draw sheet to all participating NOC delegations within 30 minutes after the draw is completed.

## 6.3. Weigh-in

Time for Unofficial Weigh-in: 15:20 - 15:50

Time for Official Weigh-in: 16:00 - 16:30

Location: Aichi International Arena Weigh-in Room

Note: In the official weigh-in for individual events, the weight of each athlete must not exceed the prescribed weight limit.

Each athlete will be allowed only one (1) weight control during the official weigh-in and must weigh within the limits of the appropriate weight category.

The official weigh-in for the Mixed Team event will be held on the day before the competition. For the Mixed Team event, athletes must weigh within the prescribed weight limits and there is a +5% tolerance for athletes (except for athletes +70kg and +90 kg categories) who competed in the preceding individual competition (provided that the concerned athletes comply with the weight limits of individual events). NO tolerance for reserve athletes who are only inscribed for the mixed team competition or who did not pass the official weigh-in for the preceding individual competition.

### 6.4. Random Weigh-in

Random weight checks can be organised before the first contest in the morning of the competition.

Four (4) athletes per weight category will be drawn. Each athlete shall bring his or her accreditation card. The weight of the athlete cannot be more than 5% higher (without judogi) than the official maximum weight limit of the category.

There will be no random weigh-in for the mixed team event.

## 7. Sport Entries

### 7.1. Eligibility

- Only NOCs that are members of the OCA are entitled to send athletes to compete in the Judo competition of the 20th Asian Games Aichi-Nagoya 2026.
- Only athletes who comply with the OCA Constitution and Rules and its Byelaw are entitled to compete in the Judo competition

### 7.2. Entry Timeline

- Entry by Sports: 12 Jun 2025 – 7 Jul 2025
- Entry by Number: 18 Jul 2025 – 16 Sep 2025
- Entry by Name (SEQ Period): 1 May 2026 – 1 Jul 2026

### 7.3. Entry Policies

- Individual: Each NOC may enter a maximum of one (1) athlete per event.
- Mixed Team: Each NOC may enter a maximum of six (6) athletes (three (3) men and three (3) women), and a maximum of six (6) reserves (three (3) men and three (3) women) in a minimum of four (4) weight categories.

If there are injuries or illness after the draw or during the competition a team can compete with a minimum of four (4) athletes. The weight categories should be as follows:

Men (3):

-73kg (-60kg, -66kg, -73kg) up to and including 73.0kg.

-90kg (-73kg, -81kg, -90kg) over 73.0kg up to and including 90.0kg

+90kg (-90kg, -100kg, +100kg) over 90.0kg.

Women (3):

-57kg (-48kg, -52kg, -57kg) up to and including 57.0kg

-70kg (-57kg, -63kg, -70kg) over 57.0kg up to and including 70.0kg

+70 kg (-70kg, -78kg, +78kg) over 70.0kg

- Total number of athletes: Each NOC may enter a maximum of 18 athletes (nine (9) men and nine (9) women), including seven (7) men and seven (7) women for Individual events, and two (2) men and two (2) women for Mixed Team event. The remaining athletes for the Mixed Team event, including reserves, must be selected from those who have participated in individual events.
- Age Requirement: To be eligible to participate in the Asian Games Aichi-Nagoya 2026, JUD athletes must be born on or before 31 December 2011. For athletes who have not yet reached the legal adult age, parental or guardian consent is required.  
NOCs that withdraw their athletes after the final entries' submission (SEQ deadline) or the team draw phase will face a disciplinary action by the OCA Executive Board.

## 8. Training Arrangement

### 8.1. Training Rules

Reservation-based/reservation-free training will be arranged for the Judo competition of the 20th Asian Games Aichi-Nagoya 2026.

Opening hours of the training venue: 09:30-16:45, 27 September – 2 October 2026 (with a 75-minute limit for each NOC).

Participating teams must reserve a training session at the SIC and specific website (TBC) before 17:00 at least one (1) day in advance.

Reservations will be accepted on a first-come, first-served basis and in principle, training slots will be allocated evenly among all participating teams.

Each team can only make one (1) reservation per day.

1. The judo event of the 20th Asian Games will be scheduled/open for pre-competition training from September 27th to October 2th,2026.
2. The daily opening time is from 9:30 to 16:45, and participating teams need to confirm their reservations at TBD Website and/or SID/SIC at least one day in advance before 17:00
3. Reservations are made on the principle of "first come, first served". In principle, the quota is equally distributed, and each participating team can't make repeated reservations on the same day.
4. If the training mat is not reserved, teams can use the mat without reservation.

## 9. Technical Officials and Jury of Appeal

### 9.1. Technical Officials

International Technical Officials (ITOs) must be accredited by the IJF/JUA, and shall be appointed or recommended by the TD commissioned by the JUA.

National Technical Officials shall be appointed by the All Japan Judo Federation (AJJF). AF has the right to appoint the Technical Delegate and the TD has the right to appoint International Technical Officials (ITOs) in coordination and approval of the OCA. In the event of any violation of the AF/IF Rules or Rules and Regulations by any participant, the OCA has the right to revoke his or her accreditation card and propose replacement of the participant concerned to the relevant party.

### 9.2. Jury of Appeal

The members of Jury of Appeal shall be appointed by the Technical Delegate commissioned by the JUA.

## 11. Protests and Appeals

Protests and appeals shall be handled as per the latest competition rules. All appeals of a technical nature will be the responsibilities of TD commissioned by the JUA. Any athlete/NOC may appeal to the Court of Arbitration for Sport (CAS), in the event that the athlete/NOC believes that there has been a violation of FIG/AUG technical rules or the OCA Constitution, as long as the appeal is not related to reversing the decision of the referee or result.

## 12. Equipment and Clothing

Equipment used and clothing worn by athletes and other relevant participants in competition must comply with the rules and regulations of the OCA and IJF/JUA. Neither athletes nor technical officials will be permitted to attach any form of commercial advertising to his or her competition uniform without prior approval from the OCA and the AINAGOC.

Each Judoka should provide two judogis, one white and one blue. All the training equipment shall be approved by the Technical Delegate.

## **13. Doping Control**

In order to ensure healthy and fair competitions and protect the interests of the athletes, the Anti-doping programme of the 20th Asian Games Aichi-Nagoya 2026 will be conducted in strict accordance with the World Anti-doping Code and the OCA Anti-doping Rules.

## **14. Victory Ceremony**

Gold, silver and bronze medals will be awarded to the athletes ranked in the top three (including joint third place) respectively.

In each mixed team event, gold, silver and bronze medals will be awarded to each of the team members in the top three teams, respectively.

XX minutes before the Victory Ceremony starts, the medalists shall be escorted to the Waiting Area to get ready for the ceremony. Medalists must wear their NOC official uniforms.

## **15. Sport Information Desk (SID)**

All sport-specific information will be available at the Sport Information Desks. They will be located at the competition venue.



## 5. OCA Constitution

### Article 52

- Eligibility Code
  - To be eligible for participation in the OCA GAMES, a competitor must:
    1. Observe and abide by the Rules of the IOC/OCA as per the Olympic Charter;
    2. Respect the spirit of fair play and non-violence and abide by the rules on the sports field;
    3. Comply with all aspects of WADA and OCA Anti-Doping Rules Code and refrain from using substances and drugs prohibited by the said organisations;
    4. The Member must ensure that any competitor in the OCA GAMES must be a national of the country of the NOC, which is entering him;
    5. Disputes relating to the determination of the country which a competitor may represent in the OCA GAMES shall be resolved by the EB, unless the eligibility code already set out in the Constitution has been fulfilled and is not in dispute.
- **Bye-law to Article 52**
  1. *All cases of infringement of IOC Rule 41, 42 and it's Bye-laws and of the eligibility code of IFs shall be communicated by the concerned Member to the OCA, to be considered by the EB whose decision will be final*
  2. *A competitor who is a national of two (2) or more countries at the same time may represent either one (1) of them, as he may elect. However after having represented one country in the Olympic, Asian continental regional or world championships recognised by the relevant IF, the competitor may not represent another country unless he or she meets the conditions set forth in sub section 4 below that apply to the persons who has changed his nationality or acquired a new nationality;*
  3. *A competitor who has represented one country in the Olympic Games, OCA GAMES , continental, regional, and world championships recognised by the relevant IF, and who has changed his nationality or acquired a new nationality, shall not participate in the OCA GAMES to represent his new country until three years after such change or acquisition;*
  4. *If a State, Country or a colony acquires independence, a country becomes incorporated within another country by a change of border or transfer of sovereignty or if a new NOC is recognised by the OCA, a competitor may continue to represent the country to which he belong or belonged. However, he may, if*

*preferred, choose to represent his country or be entered in the OCA GAMES by his new NOC if one exists. This option can only be made once and is irreversible;*

5. *In all cases not expressly addressed in these Bye-Laws, in particular those cases where a competitor would be in a position to represent a country other than that of which he is a national, or to have choice as to the country which he intends to represent, the EB makes all decisions. Decisions can be of a general or individual nature and issue specific requirements relating to nationality, citizenship, domicile or residence of the competitors, including the duration of any waiting period;*
6. *Except as permitted by the EB, no competitor, coach or official who participates in the OCA GAMES may allow his person, name and picture or sports performances to be used for advertising purposes during the OCA GAMES.*

## **Article 53**

- Necessary Conditions for representing a Country
1. Only nationals of member NOCs are eligible to represent that country in the OCA GAMES. Where a competitor's nationality is the subject of scrutinization, evidence (passport, residency & other documents) must be produced to support and meet definition of eligibility, according to the rules prevailing in the particular sport in which the competitor wishes to take part. It is not permissible for a competitor having once represented a country in the OCA GAMES or any international sports competition such as Olympic Games, Asian Games, World Games, Continental Games, Regional Games etc., to represent a different country in the future unless:
    - a. The former country or place of birth has since been incorporated in another State.
    - b. Or if he/she competed for the former country because the NOC or Chief National Organisation of their native land was not a Member of the OCA at that time;
    - c. The rules in relation to Article 49 byelaw 4 are met.
  2. Competitors will be eligible if they comply with the following qualifications:
    - a. That they were born in the country they represent.
    - b. That they are nationals or citizens of the country they represent and have lived there continuously for a period of not less than three years;

- c. That they have become naturalised in the country they represent and have permanent residence there.
3. Competitors born outside Asia cannot be qualified unless they meet conditions in 2 b & c, where applicable.

- ***Bye-law to Article 53***

The OCA will have the full authority for disqualification of any athlete in all matters other than technical.


#### **Article 54**

- Age Limit
  - There is no age limit for competitors in the OCA GAMES, unless the IF and/or AFs prescribe otherwise and is approved by the EB apart from AYG which has an age restriction of 14-17 years.

## 6. Clothing Guidelines

Based on the Olympic Council of Asia's Commercial Guidelines established by the OCA, as well as the regulations of the relevant IF/AF, the Clothing Guidelines for this competition are set forth as follows.

### 6.1. ATHLETE FRONT



#### **[Identification of the Manufacturer]**

##### ○ Clothing

##### • Judogi (jacket)

One Identification of the Manufacturer [■] will be permitted, to a maximum size of 30cm<sup>2</sup>.

The Identification of the Manufacturer on the jacket must be placed in a visible area at the bottom edge and inside the publicity zone permitted on the shoulders, on either of the shoulders.

- **Judogi (trousers)**

One Identification of the Manufacturer [■] will be permitted, to a maximum size of 30cm<sup>2</sup>. The Identification of the Manufacturer on the trousers must be placed in a visible area either at the top, on the front side or outside (20cm maximum from the waist string), or at the bottom, on either of the legs, at the front side or outside (maximum 20cm from the bottom of the lower edge of the trousers).

- **Judogi (belt)**

One Identification of the Manufacturer [■] will be permitted, to a maximum size of 9cm<sup>2</sup>. The Identification of the Manufacturer on the belt must be placed in a visible area, in one of the two edges.

- **T-shirt/Undershirt**

One Identification of the Manufacturer per item will be permitted, to a maximum size of 30cm<sup>2</sup>. The Identification of the Manufacturer on the T-shirt/undershirt must not be visible while the judogi is done up.

## **[NOC Emblem and National Identity]**

- **Additional IF/AF Specifications**

### **NOC Emblem and National Identity**

The NOC emblem or national flag [●] must be located on the left side of the jacket, at the chest level, with a maximum size of 100cm<sup>2</sup>.

## **[Homologation Marks]**

- **Additional IF/AF Specifications**

### **Homologation Marks**

The IJF approved label [◆] must appear once on each piece of clothing. It is represented by an unforgeable optical label of 15.75cm<sup>2</sup> (3.5cm × 4.5cm) certifying that the judogi complies with the IJF current rules. Only one label is permitted per item. Only the judogi having successfully passed the tests by the official laboratories and approved by IJF may be used.

The label must be fixed:

#### **For the jacket**

IJF approved label (red color) on the front side and at the bottom of the jacket, on the left side (jacket is folded on the right side), near or in the reinforced zone.


#### **For the pants**

IJF approved label (red color) on the front side and the top of the pants, close to the middle.
