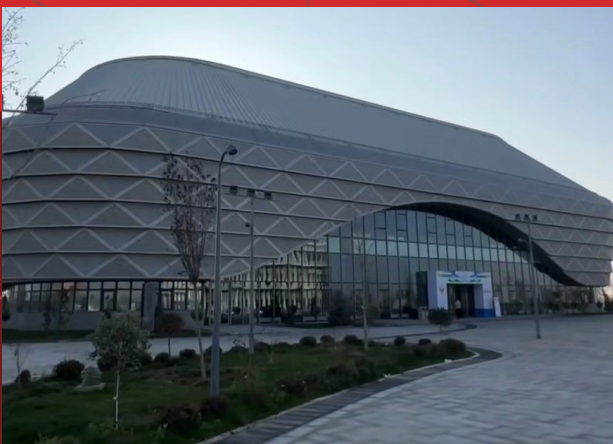

Obligatory minimum stay in the official hotel is 2 nights.

Participants are allowed to book their own accommodation. In this case for every accredited person a service fee of 100 S applies to be paid to the organizer.

In case participants book official hotel on their own and not by the organiser and pay service fee they can use local transfers from official hotel to the sports hall and back.



7. Payment:

Payment method – Bank transfer or cash (USD)

According to the IJF rule enacted on 2 December 2012 in Tokyo, “the organizing country should not request penalties fee for participating countries who cannot make bank transfers but can pay in cash upon arrival. Those countries who cannot make bank transfers should inform the LOC well in advance that they will pay cash on arrival”. All bank fees and bank transfer costs must be paid by the participating National Federation to the following bank:

If payment is being made by bank transfer the bank information must be inserted correctly and completely on the transfer document and any procedures related to the amendment of the bank transfer must be done before arrival. Delegations must ensure that all bank charges are paid at their end so that the LOC receives the correct amount of funds without any deductions. The delegation must have proof of the bank transfer, upon arrival.

8. PARTICIPATION RULES

BEFORE TRAVELLING

Passports must be valid for at least 6 months from the date of arrival.

Check if you need a visa, and if yes, request it from the LOC according to the details in the visa section.

- Book accommodation with the LOC and send a detailed rooming list. Last-minute changes can be accommodated whilst the delegation waits on the bus or outside the hotel.
- Check host country entry requirements and airline requirements (if applicable). Upload before arrival to my.ijf.org an individual Liability Release Waiver (LRW). The document can be found in the documents section under the link: <https://www.ijf.org/competition/2598>



9. MINOR ATHLETES

The National Federation is responsible for obtaining legal approval and permission for minor athletes to compete in competitions. When travelling with minors the team official/coach must have all the necessary documents in place that authorizes them to act on behalf of the parents/guardians “in loco parentis”.

10. TRANSPORTATION

The Organizer will provide land transportation from Dushanbe International Airport to the official hotels and back. During the competitions, transportation will be provided between the venue and the hotel **ONLY** to accredited delegations.

15. PARTICIPATION

All the participants must have valid IJF ID card, otherwise, registration for this event is not possible. This JUA Cup Cadets is open for all JUA/IJF Member Federations. There is no limit in the number of participants for each weight category for every federation. The competitors must be of the same nationality as the National Federation, which enters them.

16. COMPETITION RULES

Competitions will be conducted in accordance with the IJF and JUA SOR (Sports and Organization Rules), and IJF Refereeing Rules.

Men & Women – Four (4) minutes (Real Time)

The “Golden score” with no time limit. The referee’s decision is canceled.

The event (competitions and draw) will be conducted and run by the Sports and IT team (1 TD and 3 IT members) nominated by the JUA Head Sports Director. The air fare, accommodation and per diem (daily allowance) of the above mentioned ITOs will be paid by the LOC.

17. REFEREES

Each participating countries may enter TWO (2) referees at maximum. Referees must have IJF International or Continental Referee License.

Team Referee: Each delegation can enter ONE referee who holds JF International or Continental Referee License at maximum.

The hotel expense would be covered by the organizer for the referees who come with the team.

The minimum number of referees are 5 per mat, therefore 10 qualified referees will be required for two mats. Besides of the team referees, the JUA Head Referee Director will nominated 1 referee director, 2 referee commission members and qualified referees in order to guarantee the minimum number of referees for the competitions. The air fare, accommodation and per diem (daily allowance) of the above mentioned ITOs will be paid by the LOC.



18. WEIGH-IN

Official weigh-in for each weight category is held the evening before the competition day (see program). Athletes must present accreditation card, IJF ID card and his/her passport (National ID Card showing nationality and date of birth are also accepted).

19. DRAW

The draw will be conducted at 15:00 on 19 May 2026 by the TD and JUA IT group.

20. JUDO GI

All Judoka must compete in IJF Approved Judogi.

Judogi Control will be operated with a Sokuteiki prior to the fight. Judogi must have an IJF Official Label "APPROVED JUDO GI" with an optical code which cannot be falsified. The label can be controlled with an optical lamp. Each of the competition clothing articles (jacket, trousers and belt) must have an IJF official label.

National Emblem

Athletes can have their national emblem on the left front part of the jacket within a space of 100 cm².

21. INSURANCE

Each National Federation is responsible for its competitors (the control of non-pregnancy as well as the gender control are placed under the responsibility of the National Federations) and must assume all responsibility for accident and health insurance as well as the civil liabilities for their competitors and officials, during the Competition.

The organizer and JUA will not be responsible for any insurance related to the above mentioned matters. Nevertheless, the National Judo Federation staging the competitions shall take all necessary actions to provide insurance coverage against civil liability for the entire duration.

22. COACHING

Code of behavior of coaches as defined in the Sports and Organization Rules, Annex 4 will be strictly observed, inclusive the Dress Code.

Coaches are not allowed to give indications to the competitors while they are fighting.



Only during the pause time (after matte), coaches will be permitted to give indications to their athletes. - After the pause is finished, and the fight continues (hajime), coaches will have to keep silent again.

If a coach doesn't follow these rules, they can be expelled from the competition area. If the coach persists with this behavior from outside the competition area, they could be penalized.

23. AWARDS AND PRIZES

1st Place – Gold Medal with Diploma ; 2nd Place – Silver Medal with Diploma ; 3rd Place – Bronze Medal with Diploma

24. ANTI-DOPING CONTROL

The Anti-Doping Control will be carried out in accordance with the IJF Anti-Doping Rules and JUA Sports Organization Rules.
