### 1. FUNDAMENTAL PRINCIPLES

During this tournament, the Special Olympics (SO) International Judo rules apply, based on the IJF rulebook. Exceptions and clarifications are listed in these outlines.

### 2. DEADLINES FOR DELEGATIONS

### 3. EVENT INSCRIPTION AND ENTRY FEES

Special Olympics programs and Adaptive Judo clubs have received their quota confirmation following completion of the pre-registration. They are now invited to submit their full entries according to this quota by no later than 20 May 2026.

Registration will remain open until the final registration deadline or until the maximum number of athletes has been reached.

Any pre-registered places not taken up by the deadline will be re-distributed and registration will reopen until **31 July 2026** or until entry limit is reached. **Places are limited and will be given on a first-come, first-served basis.**

Entry fees - Thanks to the cooperation with Special Olympics Bosnia and Herzegovina and the Judo Federation of Bosnia and Herzegovina, no fees are expected for SO judo athletes.

Delegations are encouraged to include at least one-third (1/3) of women, and athletes from different skill levels if possible.

Athletes can enter in the following categories:

- Shiai.
- Shiai and kata.

Divisioning for shiai and kata will be combined. Entering only in kata is not possible for this event.

#### **5. PAYMENTS (FOR HOTELS) AND CANCELLATION POLICY**

According to the IJF rule enacted on the 2 December 2012 in Tokyo, «the organising country should not request penalties fee for participating countries who cannot make bank transfers but can pay in cash upon arrival. Those countries who cannot make bank transfers should inform the LOC well in advance that they will pay cash on arrival».

## 14. GENERAL INFORMATION

### INSURANCE

Please refer to IJF SOR 1.3 Insurance and Civil Liability.

Each national federation or Special Olympics Program is directly responsible for all its delegates for any event. It must assume all responsibility for accident, health and civil liability insurance for everyone under their charge during events.

Delegations are responsible to provide insurance guarantees to their delegates during any IJF event. If the SO program/Adaptive Judo Club/national federation does not provide insurance to the members of their delegation, those members shall be liable for any damages caused by or incurred to them. The LOC of the event and the IJF will not be responsible in the absence of insurance.

The LOC of the event and the IJF accept no liability for any claims of injury, illness or death arising from the travelling to and the participation in this event nor any claims relating to the cancellation of the event or medical costs related to illness that may affect a participant during the event.

### CONSENT FOR USE OF DATA/PHOTOGRAPHY/VIDEOS/FILMING

The national federation or Special Olympics Program must ensure that they have the permission of each delegate or in the case of a minor the permission of the parent/guardian.

If a delegate does not give consent for use of data, photography, videos and filming then the national federation must inform the SO by writing to Mr Miroslaw Krogulec ([mkrogulec@specialolympics.org](mailto:mkrogulec@specialolympics.org)).

Special Olympics and the IJF, together with their partners, are committed to promoting appreciation, acceptance, and equality for people with disabilities in judo. To highlight the achievements of athletes with intellectual disabilities and raise awareness, these organisations use media coverage.

All participants agree that any photos and videos taken may be used by Special Olympics, the IJF, and their partners without any temporal, geographical, or content-related restrictions. This includes publication in print media and online platforms such as websites and social media platforms.

All organisations guarantee that the content will not be distorted or discriminatory and that the dignity and integrity of the athletes will be respected at all times. This consent is given free of charge. By signing in for the event, the participant agrees to settle any claims against the aforementioned organisations or third parties, with the consent of the organisations, arising from the creation, reproduction, distribution, exhibition, or public display of the recordings.



**KEY POINTS SPECIAL OLYMPICS SHIAI RULES**

- All athletes will be divisioned into groups of equal skill level, weight and age bracket.
- SO adapted safety rules will apply, these include all prohibited actions as described in the official IJF judo rules and the following prohibited actions, all forms and variations of:
  1. Sutemi-waza, kansetsu-waza, shime-waza and sankaku-waza.
  2. All throws executed on one or two knees forward or backwards.
  3. To put pressure on the opponent’s head, neck or throat.
- In relation to penalties and prohibited actions, the referee can give a verbal warning and explain to the athlete the nature of forbidden action before giving a shido. This can be done with the assistance of the coach if deemed necessary.
- Sideline coaching for levels 1 and 2 are in line with IJF rules, however for judoka at level 3, coaches may offer encouragement throughout the contest but may only offer technical advice during “Mate!”. For judoka at level 4 and 5, technical advice as well as encouragement may be offered throughout the entire contest.
- In SO, all three (3) referees are on the tatami during the contest – one (1) main referee and two (2) corner judges.

**KEY POINTS SPECIAL OLYMPICS KATA RULES**

- Pairs only perform once (no final).
- There will be three (3) kata judges who will evaluate the performances in comparison to the others in the category. They are allowed to briefly discuss after each performance.
- All coaches need to fill out a form with all adaptations the pairs will demonstrate.
- Errors in kata that are due to disabilities (not learnable or as a result of a specific condition) are only counted once and must be filled in and justified on the form in advance by the coach.
- Level 3, 4, and 5 SO athletes are not allowed to demonstrate techniques that are not permitted in shiai, such as throwing from the knees or grabbing the trousers.

**CATEGORY COMBINING**

At registration, the exact weight of each athlete, including their judogi, must be recorded. Shiai categories may be combined if nessessary. Kata categories may be combined if nessessary. This decision will be made by the Technical Delegate from SOI.

### **ACCREDITATION**

The purpose of accreditation is to identify people and their roles at events and allow them necessary access to perform their roles. It is the personal identity document of the participant for all security and access controls.

This card contains: last (family) name, first (given) name, category Special Olympics, country, delegation and optionally a photo.

Accreditation cards may be picked up from the accreditation room.

An accredited person should never wear another person's accreditation card. The accreditation card remains the property of the IJF and can be withdrawn, with immediate effect, at the IJF's sole discretion.

### **SEWING SERVICE**

In case of non-respect of the place and persons providing this service to the delegations, the LOC, in agreement with the IJF, may refuse this service to those who were disrespectful.

### **AWARDING CEREMONY FOR SPECIAL OLYMPICS**

All participants, athletes and unified partner will be invited to the medal ceremony and get a medal, ribbon or souvenir.

### **REFEREES AND KATA JUDGES**

Referees and kata judges will be nominated by Special Olympics International.
